Precautions

• Before using the camera, please ensure that you read and understand the safety precautions described below. Always ensure that the camera is operated correctly.

• Do not aim the camera directly into the sun or other intense light sources which could damage your eyesight.

• Do not try to open the case of the camera or attempt to modify this camera in any way. High-voltage internal components create the risk of electric shock when exposed. Maintenance and repairs should be carried out only by authorized service providers.

• Do not fire the flash too close to the eyes of animals or people, especially for young children. Eye damage may result. In particular, remain at least one meter away from infants when using flash.

• Keep the camera away from water and other liquids. Do not use the camera with wet hands. Never use the camera in the rain or snow. Moisture creates the danger of electric shock.

• Keep the camera and its accessories out of the reach of children and animals to prevent accidents or damage to the camera.




Changing the Mode

You can record images and voices in the REC mode. And using the PLAYBACK mode to replay, delete, or edit images on the LCD monitor.

Switching between REC mode and PLAYBACK mode

In REC mode: press the PLAYBACK button (**0**) to switch to the PLAY mode.

In PLAY mode: press the PLAYBACK (1) or the **MODE** (**2**) button to switch to the REC mode.





When a menu is displayed, the four-way control and the **SET** button are used to make the desired settings.




